**SUBSTITUTION OF CREDIT PROVIDER – DEBT SERVICE RESERVE FUND**

Pursuant to Section 3 (iv) of the Authority's Continuing Disclosure Agreement, dated December 1, 2004, the administrator hereby provides this notice related to the substitution of the credit provider for the debt service reserve fund (Reserve Fund). Pursuant to an agreement among The Mills Limited Partnership ("TMLP"), Pittsburgh Mills Limited Partnership and the Authority, the Authority has terminated the Forward Delivery Agreement with SunTrust Bank, N.A. and TMLP has delivered a Letter of Credit issued by Bank of America N.A., for deposit to the Reserve Fund established and held to secure the payment of the Series 2004 Bonds as provided in the Indenture of Trust dated December 1, 2004.

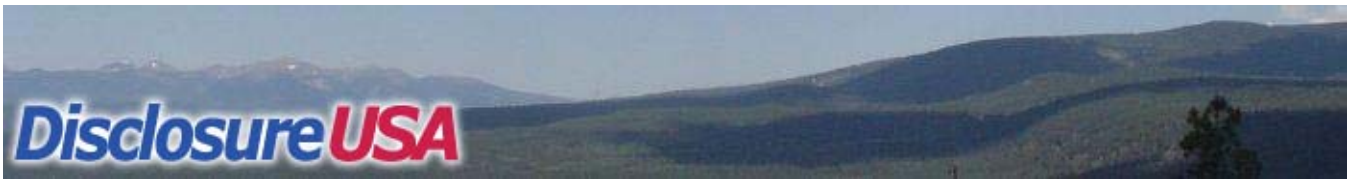
